# OUR EFFECTIVENESS IN COMBATING SLAVERY AND HUMAN TRAFFICKING

We will use the following measures to assess how effective we have been to ensure that slavery and human trafficking is not taking place in any part of our business or supply chains:

- · Completion of audits;
- · Communication and personal contact with our suppliers to assess their understanding of, and compliance with, our expectations.

### **TRAINING**

To ensure that relevant staff are aware of Modern Slavery, appropriate training has been provided for recruitment staff. We will continue to roll out appropriate training for targeted staff in the future. We have published the AFIG Policy on Slavery and Human Trafficking on our intranet to inform our employees and to encourage them to raise concerns about any issue or suspicion of modern slavery in any parts of our business or supply chains.
